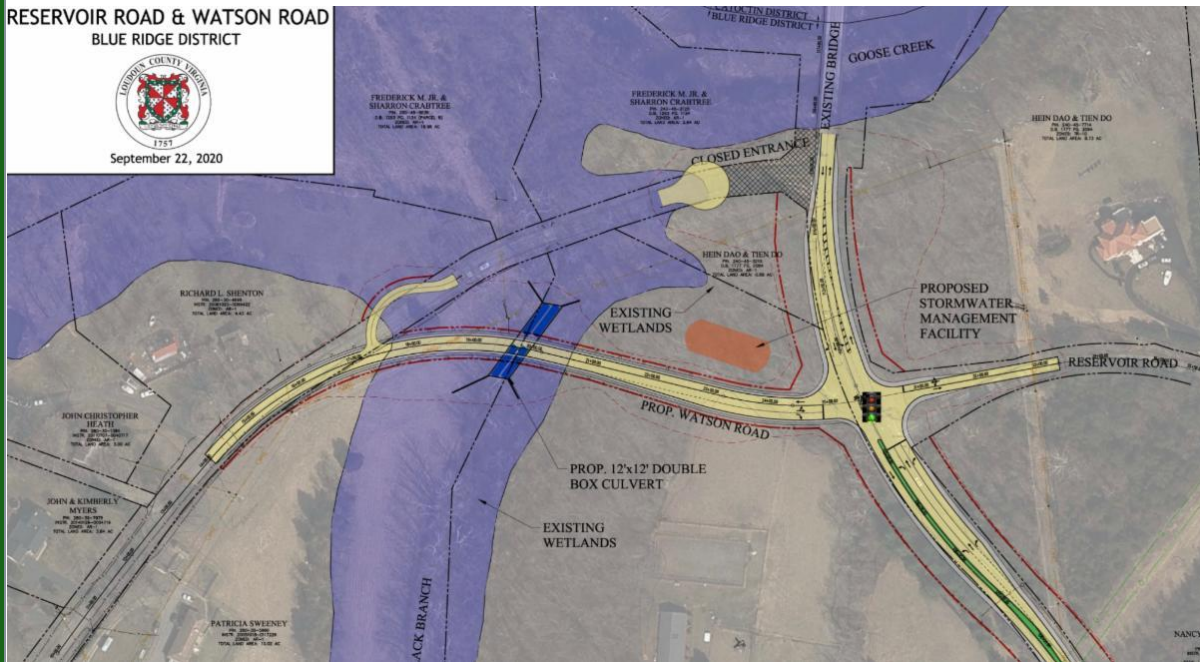

On Tuesday, September 22, 2020, from 6:00 – 7:30 pm, staff from Loudoun's Department of Transportation and Capital Infrastructure (DTCI) will conduct an online public meeting to present their plans for the Evergreen Mills/Watson/Reservoir Road intersection realignment and traffic signal project.

Members of the public are invited to attend the online meeting to learn, ask questions, and provide input to DTCI.

The project includes:

- **Widening of existing Evergreen Mills Road from approximately 0.10 miles south of Reservoir Road to the southern end of the Goose Creek bridge**
- **Realignment of the northern end of Watson Road to intersect with Evergreen Mills Road slightly north of the current Evergreen Mills and Reservoir Road intersection.**
- **Slight realignment of the southern end of Reservoir Road to intersect with Evergreen Mills Road just north of the current Evergreen Mills and Reservoir Road intersection.**

- **Construction of a proposed traffic signal at the new Evergreen Mills Road/Watson Road/Reservoir Road intersection.**

Project Background

The project is designed to improve lines of sight and safety along this segment of Evergreen Mills Road, while adding a traffic signal, along with right and left turn lanes from Evergreen Mills Road onto Watson Road and Reservoir Road.

The project is an existing Capital Improvement Program (CIP) project that was also identified as a recommendation in the [Evergreen Mills Road Safety Audit and Improvements](#) completed in 2019.
