Loudoun Election Officials Remind Voters of Proper Procedures for Absentee and Early Voting



Loudoun County election officials remind voters of the proper procedures for absentee voting and early voting for the November 3 general election.

"There are three things that appear to be causing some concern and confusion among voters right now: absentee ballot witness signatures, which envelopes are required for return and how to participate in

early voting," said Loudoun County General Registrar Judy Brown, who provides the following information:

Absentee Ballot Witness Signature Requirement Waived

Due to health and safety concerns brought on by the COVID-19 pandemic, the witness requirement was recently waived. However, the requirement is still listed

in the instructions, with the provision that people may opt out of the requirement if they cannot safely obtain a witness signature.

Follow Instruction and Use the Return Envelope

Brown reminds voters who have received an absentee ballot to make sure they follow the instructions for filling it out. When completed, they should seal the ballot in the 'B' envelope and complete the required information and then seal the 'B' envelope in the return envelope, which is the one with the purple stripe.

Early Voters Do Not Have to Apply in Advance

Anyone who would like to vote early in person may do so without an appointment or application. The last day to vote early in person is Saturday, October 31, 2020.

The Secretary of Commerce has announced a target date of **October 5, 2020** to conclude 2020 Census self-response and field data collection operations.


Loudoun's response rate has now reached 82% but we need to keep going!


Updates from LCPS

LCPS Expands Tech Support for Distance Learning

Loudoun County Public Schools (LCPS) Department of Digital Innovation (DDI) has expanded its support services to community locations across Loudoun County.

These expanded services are meant to help make sure students' technology is working properly so that they can effectively participate in distance learning.

LCPS has 120 digital experience specialists working at 11 sites to provide technology support to students and staff members. These specialists are handling



roughly 650 appointments per day across the school division, with about 200 devices per day sent out for repair.


LCPS Connect U: Connecting Students to Colleges, Universities, and the Military

"Demystifying COVID-19" Lecture Series

In the final talk in this series, Rasmussen will review some of the different treatments and vaccines in development, and what to expect from these ameliorative efforts.

Metro Opens Public Comment Period on Service Cuts as Federal Funding Support Ends

Metro has officially opened the public comment period and announced the many ways the public can make their voice heard regarding the impact of COVID-19 budget cuts that must be considered as federal funding support ends.

Due to the pandemic's impact on ridership and revenue, Metro is heavily dependent on CARES Act funding that will run out by the end of the year. As a result, Metro's Board of Directors must prepare to cut more than \$200 million from the transit agency's annual operating budget, something that is only possible through a combination of service cuts, reduced hours, layoffs, furloughs, and internal cost-cutting measures.



Metro is encouraging anyone impacted by these changes to make their voice heard as part of the official Public Comment period, which runs through 9 a.m. October 19, 2020.

Virginia Department of Health's Pandemic Metrics Dashboard




The Pandemic Metrics Dashboard compiles various data sources related to the ongoing COVID-19 outbreak in Virginia into understandable metrics for burden, trend, and extent of transmission.

These metrics are provided at the region level in Virginia.

- Burden is the measure of disease and its impact on a community.
- Trend is a measure of how individual metrics and the overall situation are changing over time.
- The extent of transmission is a new measure that consolidates a variety of data sources into one metric.

- To receive email updates on COVID-19, visit loudoun.gov/coronavirus.
