## **Additional Safety Improvements Added Along Evergreen Mills and Watson Roads**

**6 New Pole Mounted Speed Display Signs Installed**

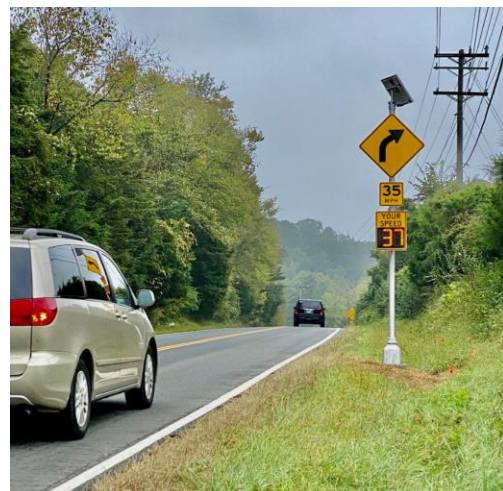


I'm happy to share that another improvement recommendation from the Evergreen Mills Road and Watson Road Safety and Operational Study has now been installed. This safety measure includes six new Pole Mounted Speed Display (PMSD) signs along Evergreen Mills and Watson Roads. The

now functioning signs were installed over the past few weeks.

The PMSD's come from a list of Tier 1 short term improvements approved by the Loudoun Board of Supervisors on March 5, 2019. The Tier I short term improvements can be viewed on [pages 9-11](#) of the March 5, 2019, Board of Supervisors, Business Meeting Action Item #9. The Tier I short term improvements items listed include those that can begin construction with the \$1.2 million previously allocated via the FY2018 Fund Balance appropriation made by the Board. This list of improvements are being constructed by VDOT, pending availability of VDOT contracts, state forces, and scheduling.

The Tier I short term projects include improvements such as: hot spot and systemic recommendations, traffic signal modifications, flashing warning beacons, pole mounted speed display signs, signage, retroreflective devices and materials, pavement markings, variable message sign (VMS), and design of enforcement areas.
