Proposed Silver Line Metro Connection Bus Routes Brambleton Options 1 and 2

Both options for a Brambleton route provide service to the south side bus bays at the Asbur Metro Station during peak commuting times, approximately 5 AM - 9 AM for the morning service and 3 PM - 9 PM for the evening service. One bus would travel in continuous, circulating loops.

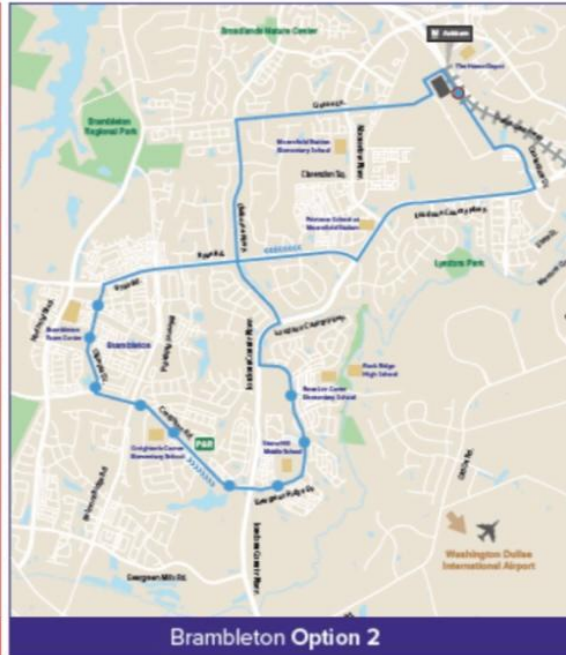
