## Planned Venting at Loudoun Compressor Station Tomorrow Morning

Good afternoon!

I wanted to make you aware that on **Tuesday, March 9th, at 9:00 a.m.**, *Berkshire Hathaway Energy Gas Transmission and Storage (BHE GT&S)* will conduct a scheduled natural gas venting from its Loudoun Compressor Station located along Watson Road. Below is a message from them regarding the scheduled venting operation:

*This is a message to our neighbors in the vicinity of Berkshire Hathaway Energy Gas Transmission and Storage (BHE GT&S) Loudoun Compressor Station on Cove Point Lane off of Watson Road in Loudoun County:*

BHE GT&S will be performing a required annual test of the Emergency Shutdown System at the Loudoun Compressor Station. This requires venting natural gas from the piping within the station. The compressor station's silencers and carbon filters will be used to mitigate noise and odor during the test.

The test is scheduled to begin at **9:00 a.m., Tuesday, March 9th**, and is expected to last less than 60 minutes.

Thank you for your understanding as we work to ensure the safe and efficient operation of our facilities.
