May 25th Board of Supervisors Transit Summit

The Loudoun County Board of Supervisors has scheduled a Transit Summit for Tuesday, May 25, 2021, beginning at 6:00 p.m.

The summit is intended to provide Board members with a dedicated opportunity to discuss transit issues, one of the Board's strategic focus areas.

Representatives of the Department of Transportation and Capital Infrastructure will provide updates on the following topics, including:

- **The opening of the Metrorail Silver Line Phase 2 in Loudoun County**, which will include a briefing from Washington Metropolitan Area Transit Authority General Manager Paul Wiedefeld.

- **Comments on transit-related matters from several advisory boards**, including the Commission on Aging, the Disability Services Board, the Loudoun Health Commission and the Transit Advisory Board.
- **Findings from the Unmet Transit Needs of Seniors and Disabled Residents Study.**
- **Overview of the Loudoun County Transit route design and modification process** to illustrate how transit routes are created to better meet community needs.
- **Results of a study to identify strategies for the best use for the county's park and ride lots** as Metrorail extends into Loudoun County.
