Latest Update Regarding the Colonial Pipeline Cyberattack

Last night Colonial Pipeline issued a [statement](#) indicating that it had initiated the restart of pipeline operations at approximately 5:00 p.m.

Colonial Pipeline stated: "Following this restart, it will take several days for the product delivery supply chain to return to normal. Some markets served by Colonial Pipeline may experience, or continue to experience, intermittent service interruptions during the start-up period. Colonial will move as much gasoline, diesel, and jet fuel as is safely possible and will continue to do so until markets return to normal."

My office will continue to provide updates if warranted; however, we continue to expect the situation to resolve itself within the next week.

Yesterday's Update Sent: May 12, 2021

The Board of Supervisors and Loudoun County staff are aware that some area gas stations have run low or completely out of gasoline stemming from last Friday's widely reported ransomware cyberattack resulting in temporary shutdown of the Colonial Pipeline, which serves as a major source of gasoline along the east coast of the U.S.

Currently, the impact of this situation is expected to last a few more days and be resolved within a week.

On Tuesday, May 11, Governor Ralph Northam [declared a State of Emergency](#), which provides the Commonwealth of Virginia some flexibility in addressing supply shortages over the coming days. As such, Loudoun County has taken steps to ensure an adequate amount of fuel for the continuity of County government operations.

Yesterday, the U.S. Environmental Protection Agency (EPA) [took action](#) to help alleviate fuel shortages in Virginia and other impacted states.

Loudoun County is authorized by the Code (Virginia Post-Disaster Anti-Price Gouging Act § [59.1-525](#)) to investigate any incidents of price gouging. Incidents of price gouging may be reported to the Office of the Attorney General through its [consumer protection website](#).

At this point, we ask for patience as the situation continues to evolve. The American Automobile Association (AAA) encourages members of the public not to panic, reporting that panic buying can create spot shortages at stations during the temporary pipeline shutdown.
