## Ryan Road Updates

### Ryan & Olympia Signal to be Activated in July

#### Ryan & Olympia Signal to Activate in July

The new traffic signal at the intersection of Ryan Road and Olympia Drive is being built as a proffer by the Brambleton Developer and is scheduled to be operational in July of 2021, upon final approval from VDOT.



#### Ryan Road Widening Continues

Ryan Road between Northstar Drive and Evergreen Mills Road is planned to be improved to a four-lane, median divided roadway with shared use paths on both sides of the roadway.

One portion of the road is being constructed by the Brambleton Developer as proffer.

In 2019, I worked to successfully add the remaining portion as a new county infrastructure project. Since that time it has remained listed on the County's approved six-year Capital Improvement Project (CIP) plan with currently approved design, land acquisition and utility relocation funding, while it awaits final construction funding.

Here's are the latest updates on these two projects:

**Ryan Road Widening (Northstar Dr to Beaverdam Dr):**

- Being constructed by the Brambleton Developer as a proffer.
- Utilities along the route have begun to be relocated.
- The developer currently anticipates completion of the road widening project in July of 2022.

**Ryan Road Widening (Beaverdam Dr to Evergreen Mills Rd):**

- Widening will occur as part of the County's CIP program.
- Project design by County Traffic Engineers is expected to begin in FY2022. Project design is typically a two-year process that includes multiple opportunities for public input.
- Land acquisition and utility relocation activities are expected to follow, which are currently planned to extend through FY2026.
- Efforts to obtain final construction funding will continue in next year's CIP budget discussion and approval process.
