**UPDATE: Foggy Bottom Road Vehicle,  
Bicycle & Pedestrian Safety Improvement**

**Road Flagging for Narrow Bridge Widening Continues  
(Weekends & Holidays Excluded)**

Sent: July 27, 2021

VDOT continues to conduct road flagging operations on Foggy Bottom Road, immediately south of Snickersville Turnpike, as they convert the narrow one-lane bridge over Butchers Branch stream into two lanes for enhanced vehicle, bicycle and pedestrian safety based on existing use conditions.



**VDOT will maintain one-lane alternating traffic in each direction during road flagging operations**

**which are scheduled (weather permitting) for 8:30 am to 3:30 pm daily on the following dates:**

- **Monday, July 26 through Friday, July 30**
- **Monday, August 2 through Friday, August 6**

**No work is scheduled to occur on weekends and Holiday's.**
