County to Assume Responsibility for Billing & Collection of Real & Personal Property Taxes for the Towns of Purcellville & Hamilton

**Residents & Businesses will no longer receive separate tax
bills from these Towns**

For your convenience effective January 1, 2022, the Loudoun County Treasurer's Office is assuming responsibility for assessing, billing and collection of real estate and personal property taxes for the towns of Purcellville and Hamilton.

This new process is designed to make things easier for the residents and businesses of our Towns by streamlining the tax process! And it is the result of successful legislative initiatives led by Treasurer Zurn and Commissioner Wertz' Office that I strongly supported at both the state and local levels.

New Payment Process for Personal Property & Real Estate Taxes for Hamilton & Purcellville

Loudoun County is assuming responsibility for assessing, billing & collecting personal property & real estate taxes in Hamilton & Purcellville, effective 01/01/22.

Residents and businesses in Hamilton and Purcellville will now begin receiving combined semi-annual bills that include all county and town administered taxes as separate line items. Each line item will show the respective county or town tax rate and amount. **Taxpayers will then remit a single payment for the total amount of taxes to the County of Loudoun. The new process will apply to the first half tax bill due May 5, 2022.**

The Treasurer's Office will process the tax payments received and transmit the appropriate amount to the towns of Purcellville and Hamilton. The Treasurer's Office will also undertake any collection efforts for all accounts which may become delinquent after the January 1, 2022, effective date. Purcellville and Hamilton will continue with delinquent collection efforts for all taxes due for 2021 and prior years.

The first phase of this initiative began in 2019 with the county assuming responsibility for real estate taxes in the towns of Hillsboro, Leesburg, Lovettsville, Middleburg and Round Hill. In 2020, the

county assumed responsibility for personal property taxes in Leesburg and Round Hill and business tangible personal property taxes in Leesburg, Middleburg and Round Hill.
