## **Hal & Berni Hanson Park Update!**

**Still on track for planned Spring of 2022 opening!**

Crews continue construction work on the various structures and features throughout Hal and Berni Hanson Regional Park, currently under construction along Evergreen Mills Road in Arcola.



Throughout the park, crews are currently installing underground utilities, sports netting around the athletic fields, site concrete at site stairs, plazas and sidewalks. Crews are making progress paving the asphalt trails and installing the turf irrigation systems, the athletic field turf and athletic field turf covers.

Work continues on the on the interior and exterior of various structures throughout the park. At Hanson House, crews are building out the electrical room and insulating exterior and interior walls. Leading into the park, construction for the Evergreen Mills Road turn lanes is ongoing, including the installation of the concrete curb.

**The park is still on track for estimated completion in the Spring of 2022.**



### **About the Hal and Berni Hanson Regional Park**

This project includes the design and construction of a new 257-acre regional park located along Evergreen Mills Road in Arcola, between the Brambleton and Willowsford communities.



When completed, the park will feature:

- 17 lighted athletic fields, including two artificial turf fields and one cricket field;
- five ponds;
- the historic Hanson House;
- an event lodge and nature center;
- a skate plaza and disc golf course;
- a splash pad and playground with inclusive features; and

- over 75 acres of passive recreational space.
