Detective Bucco went out of his way to help my wife and I with funds being fraudulently withdrawn from our SunTrust account on 9/3/21. SunTrust told us all would be resolved within 15 calendar days. Fast forward 46 days and no help or update from SunTrust. We called Detective Bucco yesterday and between yesterday and today gave us more info than any SunTrust employee. He has stayed in constant contact with us and I did not want his efforts to go unnoticed. So thankful for him. Professional and super responsive.

My son and I were leaving the park, behind what I presume to be the white truck of the Loudoun County Parks & Recreation employee who locked us in the park. Deputy Plummer was dispatched to help us and he was most gracious about the incident, which I'm sure took him away from helping others in need. Thoroughly appreciate his professionalism and courtesy. Thank you for coming to our rescue!

My children alerted me to the fact that there was an unknown individual on my neighbors front porch. Considering the time of day and the fact that she lived alone this seemed out of the ordinary. I made contact with this individual while the owner of the residence contacted the Sheriff's office. This individual did not seem to pose any immediate threat, but it was still very concerning to the owner of the residence. I understand that a call of this nature can sometimes seem trivial, but the extremely quick law enforcement response and action was greatly appreciated.
