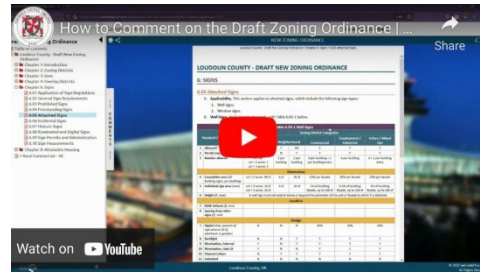

In addition to the 90-day public engagement period, the public will also have the opportunity to provide comment at a Planning Commission public hearing anticipated to take place in fall 2022 and a Board of Supervisors public hearing, which is slated to take place in late 2022.

### **About the Loudoun County Zoning Ordinance**

On June 20, 2019, the Loudoun County Board of Supervisors adopted the Loudoun County [2019 Comprehensive Plan](#). This plan is our County government's guide for land use and transportation policy.

The Loudoun County Zoning Ordinance defines and implements those land use and design standards for all unincorporated areas of the county.

This Zoning Ordinance Rewrite Process provides an added level of specificity based on the 2019 Comprehensive Plan's goals, policies and actions.

I want to thank County staff, involved community organizations, our advisory bodies and the Zoning Ordinance Committee for all of their hard work and many hours of engagement on this effort!

The County's Zoning Ordinance Committee has served as a sounding board to staff for potential ordinance changes throughout the Zoning Ordinance Rewrite process.

Two rounds of preliminary public engagement have already been completed, which included 56 in-person and remote public input sessions with community groups and advisory bodies.

**I encourage members of the public to use this public engagement period to actively involve themselves in the Zoning Ordinance Rewrite process in order to make sure their voices are heard as part of this very important public process!**
