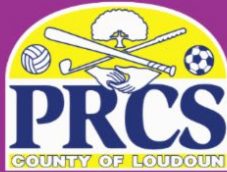

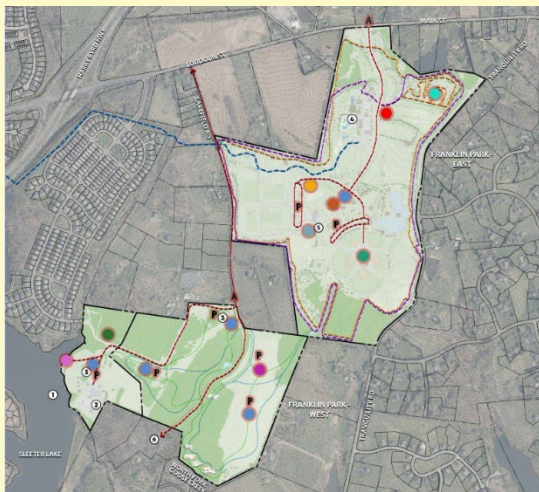

With the county's recent acquisition of 103 acres adjacent to the current park, planners have identified amenities that may potentially be added to the newly enlarged park, including equestrian facilities, additional hiking trails, and improved parking and restroom facilities.

Through collaborative efforts between the Town of Round Hill and Loudoun County, this master planning process will also evaluate potential connections between the existing park, the new "Franklin Park West," and the Town's Sleeter Lake Park.
