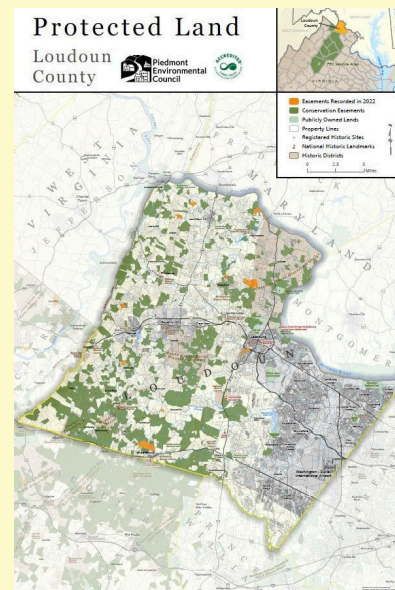
## Attend the **FREE Land Preservation Through Conservation Easement Seminar**
