





He was additionally charged with possession of narcotics and possession of drug paraphernalia as he was also found in possession of narcotics and drug paraphernalia at the time of his arrest. The credit card fraud charge stems from a theft back on December 7 when residents on Columbus Street reported several vehicles were entered and rummaged through. Credit cards were taken from one of the victim's wallets and used at a local store. Through the course of the investigation detectives were able to identify the suspect. Detectives are working to determine if the suspect is connected to similar thefts from vehicles in the area. Meade remains held at the Loudoun County Adult Detention Center on a \$7,500 bond. 
