



FY 2017 Loudoun County Budget Process

On February 10th, Loudoun County Administrator Tim Hemstreet proposed his Fiscal Year 2017 budget to the Loudoun County Board of Supervisors.

Tax Rates

The primary property tax rates that are being considered by the board are:

- Proposed Budget: **\$1.135**
- Recommended Budget: **\$1.140** (County Only) or **\$1.150** (County+LCPS)
- Advertised Budget: **\$1.170**

Note: the homeowners equalized tax rate is \$1.140.
