

Fiscal Year 2019 Loudoun County Budget Process

On February 14th, Loudoun County Administrator Tim Hemstreet presented his proposed Fiscal Year 2019 operating budget to the Loudoun County Board of Supervisors.

Mr. Hemstreet's proposal totals more than \$2.3 billion in appropriations for the General County Government and Loudoun County Public Schools combined. FY-19 Equalized Tax Rates

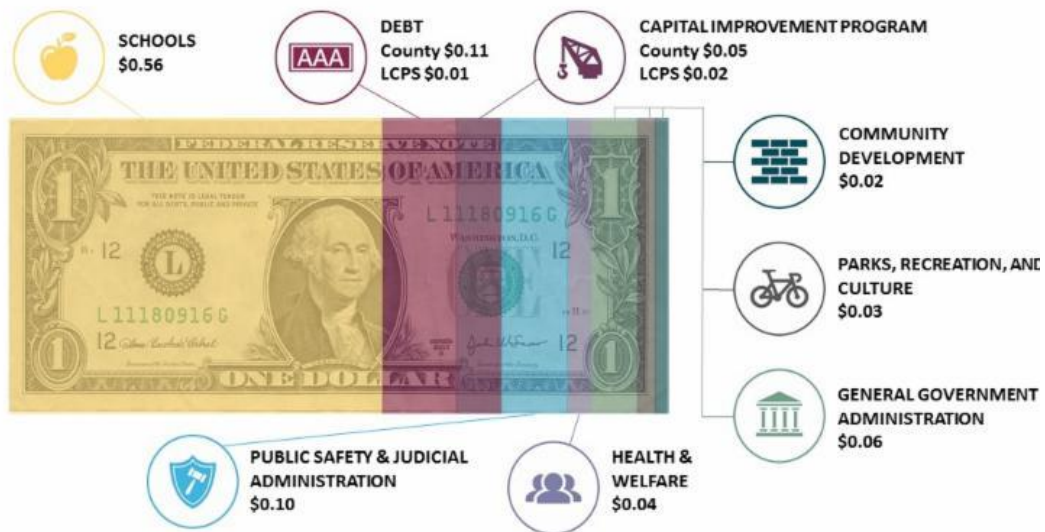
The homeowners equalized tax rate is the rate at which the average homeowners real property tax bill for FY-19 would be about the same as it was for FY-18. The overall equalized tax rate is calculated by including commercial tax assessments into the equation. This years rates are:

- Homeowners equalized tax rate is \$1.095
- Overall equalized tax rate is \$1.09

The below graphic is based on the proposed equalized tax rate of \$1.09.
