
My name is Daniel A. Reilly, Adj. Professor at George Mason University Fairfax Virginia. I am a retired FBI agent who worked for 45 years in law enforcement in the Washington DC. Metropolitan area. I had the pleasure of working directly with almost every police department and sheriff's department in this area and spent significant time investigating Washington DC Street gangs. For the past three years I have been an instructor at George Mason, University. During that time, I had the opportunity to meet and correspond with Lieutenant Steven D. Remick of your department.

This Spring Semester I was asked to teach a class on Policing in America and I have to admit that my own experience with the responsibilities of uniformed patrol officers was limited to working with patrol officers on various arrests, traffic interdictions, intelligence gathering, and analysis of organized criminal activity in neighborhoods or sectors of our local communities. In order to fill in this gap of experience I asked Steve to recommend a panel of deputies from Loudoun County to provide my students with insight about their day to day responsibilities. Steve recommended Det. David Orr, Deputy Michael Rivera, and Deputy Trevor Nelson

of your department. These three fine law enforcement officers volunteered to help me in my class and provided three excellent examples of professionalism and integrity to my students. My students are Juniors and Seniors in the Criminology Law and Society department and are seeking BS degrees in that area of Criminal Justice Studies. Many of my students are interested in a career in law enforcement. David, Michael and Trevor provided a lively and instructive dialogue to the students who asked very pointed questions about the difficulties facing today's police officers. Their contribution to my class was extraordinary and I hope you will convey to them my personal thanks and an affirmation of a job well done.

I have found that teaching college students about the practical problems faced by law enforcement helps them make final decisions in their search for a proper career.
