To Whom It May Concern,

My husband and I have been residents of Purcellville since 2000 and have always appreciated our police force. We are grateful for your officers as well. You have been in our fervent daily prayers. In a time when our police officers are getting a "bad rap," we want to take a moment to thank you.

Nearly five years ago, we adopted two teenage sisters out of Ethiopia. They have adapted well in Loudoun County, and our older daughter, Lydia, was one of the recipients of the Miss Purcellville Police Department scholarship in December of 2014. However, our younger daughter suffers from PTSD, and since August at least four of the heroes/heroine of the Purcellville Police Department (*and a tall, dark handsome man from the sheriff's department*) have responded to our call for help in our home. Two of those occasions being in the middle of the night/wee hours of the morning.

Unfortunately, my mental state of being at the time could not retain the names of these caring, valiant men and woman, so please forgive me. On the occasion your officer joined with the Purcellville Police, he responded quickly and efficiently, and had it not been for these men's immediacy and skill, I am not sure we would still have our daughter with us. Rose was hostile, belligerent, profane and violent in resisting the calm, caring help of the officers. I apologize to you for her disrespect and bad behavior. And I thank you from the bottom of my heart for your professional, skillful execution of protecting her and seeing she got where she needed to go safely.

Unfortunately, Rose is a hurt little girl inside with deep emotional, psychological needs. She has spent the last month in the hospital and is now receiving continued care through the hospital's after school program. We believe she is doing better, and she would not be here to heal, were it not for your efforts.

Words are not adequate to express our deep appreciation for all you have done for our family and to keep us safe. You are our unsung heroes, and we are so very grateful!!! Thank you, thank you, thank you!

I sincerely appreciate your continued support as an affiliate of the Northern Virginia Internet Crimes Against Children (NOVA/DC ICAC) Task Force.

As you are aware, the Loudoun County Sheriff's Office in partnership with the NOVA/DC ICAC Task Force recently led pro-active criminal investigations against internet predators as part of the national Operation Broken Heart III initiative. Through the week of April 11 to 15, the NOVA/DC ICAC Task Force and the Loudoun County Sheriff's Office received onsite support from the FBI, US Marshals Service, Virginia Office of the Attorney General, the Loudoun County Commonwealth Attorney's Office, the Town of Herndon Police Department, the Prince William Police Department, the Fairfax County Police Department and investigators from several other task force affiliate agencies.

Your detective, Patrick Beaver, organized the pro-active, secured the location, and coordinated the participating agencies which all led to a very successful operation.

The following is a brief summary of the outcome of the investigations:

The task force executed three search warrants which yielded large amounts of evidence containing obvious child pornography. These investigations continue and arrests are expected from all three search warrants.

Three adult males were arrested in three separate incidents during the operation for traveling to meet what they thought were juvenile females for the purpose of having sex. A total of five charges for use of a communication device to entice a minor, and two charges of production of child pornography resulted. The search of one of these

individuals' vehicle also produced a hand gun, a stun gun, and other paraphernalia. All three were taken into custody without incident.

Undercover detectives are still working with a suspect in Georgia who has discussed making plans to travel to Virginia to have sex for hire with an undercover detective's two children, ages 4 and 8. This case is on-going and will require coordination with the Tactical Enforcement Unit/Rapid Response Unit (TEU/RRU) for undercover work.

An undercover detective posing as a 14 year old female has been contacted and is being groomed by an alleged 18 year old female for prostitution. The female suspect has referenced another juvenile involved in prostitution. Identification has not yet been made. This case is pending and will require coordination with TEU/RRU for undercover work.

Several additional arrests were also made by the ICAC Task Force:

- A Town of Herndon arrest based on a federal warrant for production of child pornography, served by NOVA/DC ICAC and Homeland Security Investigations.
- A Prince William man was arrested for production of child pornography
- A juvenile in Prince William was also arrested for production of child pornography

Again, I thank you and Detective Beaver for all you do in support of the NOVA/DC ICAC Task Force and look forward to continued success as a result of this partnership.

wanted to end her life because she had lost her children (I later found out her boyfriends cruel mother has temporary custody) and needed someone to talk to. I was currently picking up my husbands children and was unable to discuss what was going on in their company so I sent her a reply stating such and told her to hang tight and that I would call her shortly. When I got home and was able to call her she didn't answer her phone and that worried me. So not knowing exactly how to handle the situation, I called the police. I was informed that it was out of the local jurisdiction but the officers would do their best to handle the situation. Officer Gadell came to our home and attained what little information I had and stated that he would do his best to contact my cousin. My cousin resides in Nevada. I am very pleased how professional Officer Gadell handled the situation. He showed genuine compassion and concern, beyond what I think would be expected of a law enforcement officer. As prior military, I can relate. I believe there is a difference between showing up because that's what's expected of you, and stepping up to the plate because your heart is in it. I feel he went above and beyond what he had to do. Because he had limited information he told me he would do his best and he did. He kept his word and followed the situation through - that alone is a BIG deal. He was able to contact my cousin and spoke with her heart to heart. She is doing better now and getting the counseling she needs. I think she just really needed someone to talk to. I do want to say thank you to everyone involved - from the 911 dispatcher to the person filing the report. And again, a special thanks to Officer Gadell for going above and beyond.


