I want to take a brief moment to make you aware the actions of Deputy Taylor and Deputy Payne. I came upon a Felony hit and run at the intersection of Route 7 and Sterling Blvd. I only had direction of travel and brief description of the suspect vehicle. Deputy Taylor and Deputy Payne noticed a vehicle pulled off on the side of the roadway just down from this intersection that matched the description. Upon pulling up to the vehicle, they noticed a male subject running from the vehicle. Both units engaged in a foot pursuit over a barrier wall, down the street, through back yards and over fences. Moments later the suspect was apprehended without incident by these 2 deputies. The radio traffic in my opinion was "on point" with updates and their location.

Explain the circumstances on why you are paying this compliment:\*

I can't say enough about how wonderful and compassionate Deputy Erick Ambrose was on Thursday evening after a deer hit my car on Rt. 15, about 2.5 miles south of the Maryland/Virginia state line heading toward Lucketts/Leesburg. Although I wasn't physically injured I was kind of shocky, distressed and in disbelief over the incident because I never even saw the deer before or after I hit it with my car. Rt. 15 is a dark and windy two-lane highway with no shoulders on the road and I had to drive about a mile to find a lane to pull into. As I was inspecting the damage to my car, Deputy Ambrose pulled in behind me and immediately asked me if I was okay. He continued to talk to me and calm me down. He filed an incident report and gave me a case number to give to my insurance company. He also gave me a name of an auto body shop where I could have

my car towed. He provided details of the incident while I was on the phone with my insurance so that my claim was accurate for time of accident, exact location, damage, etc. He followed me for another mile down this dark, creepy highway to a small gas station in Lucketts so I would be in a lit area while waiting for the tow truck. All in all he probably spent about 45 minutes with me--keeping me calm and focused, ensured my personal safety and entertained me with a story about how his brand new car was damaged in the DMV parking lot by a 15-year old who had just gotten his learner's permit. What a great asset Deputy Ambrose is to the Loudoun County Sheriff's Office. We Virginians need more New Yorkers like him working in law enforcement.
