

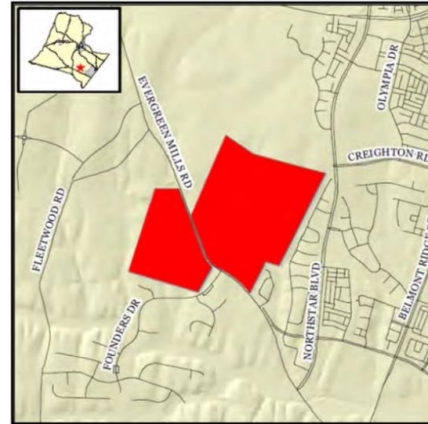

New 257 Acre "Hal & Bernie Hanson Regional Park" Approved & Fully Funded Last Night!

Friday, May 24, 2019



Good morning!

I'm happy to share with you that last night my colleagues and I took action to **approve and fully fund Hal & Bernie Hanson Park!** This new regional public park will provide both active and passive

recreation on 257 acres located on both sides of Evergreen Mills Road, between the Brambleton and Willowsford communities!

The project will provide for design & construction of:

- 10 rectangular grass soccer fields
- 1 cricket field
- 4 tennis courts
- 4 diamond fields
- 2 championship turf fields
- 1 basketball court
- 2 playgrounds
- 1 splash pad
- 1 skate plaza
- 9 restroom facilities
- Grandstands
- Concession buildings
- Park offices
- Maintenance facilities
- Pavilions
- Picnic shelters
- Dog parks
- A park lodge
- A nature center
- Restoration of the historic Hanson Farm House
- Evergreen Mills Road improvements
- 75 acres of passive park with paved & natural trails
- Restoration of 5 existing lakes

Construction is expected to begin on June 30, 2019, and end around Spring of 2022.

As a member of the Board's Finance subcommittee, I advocated strongly for approval and full funding of this project since 2016. I'm therefore very happy to share this news with you, as the Park will be a great asset for all of Loudoun!

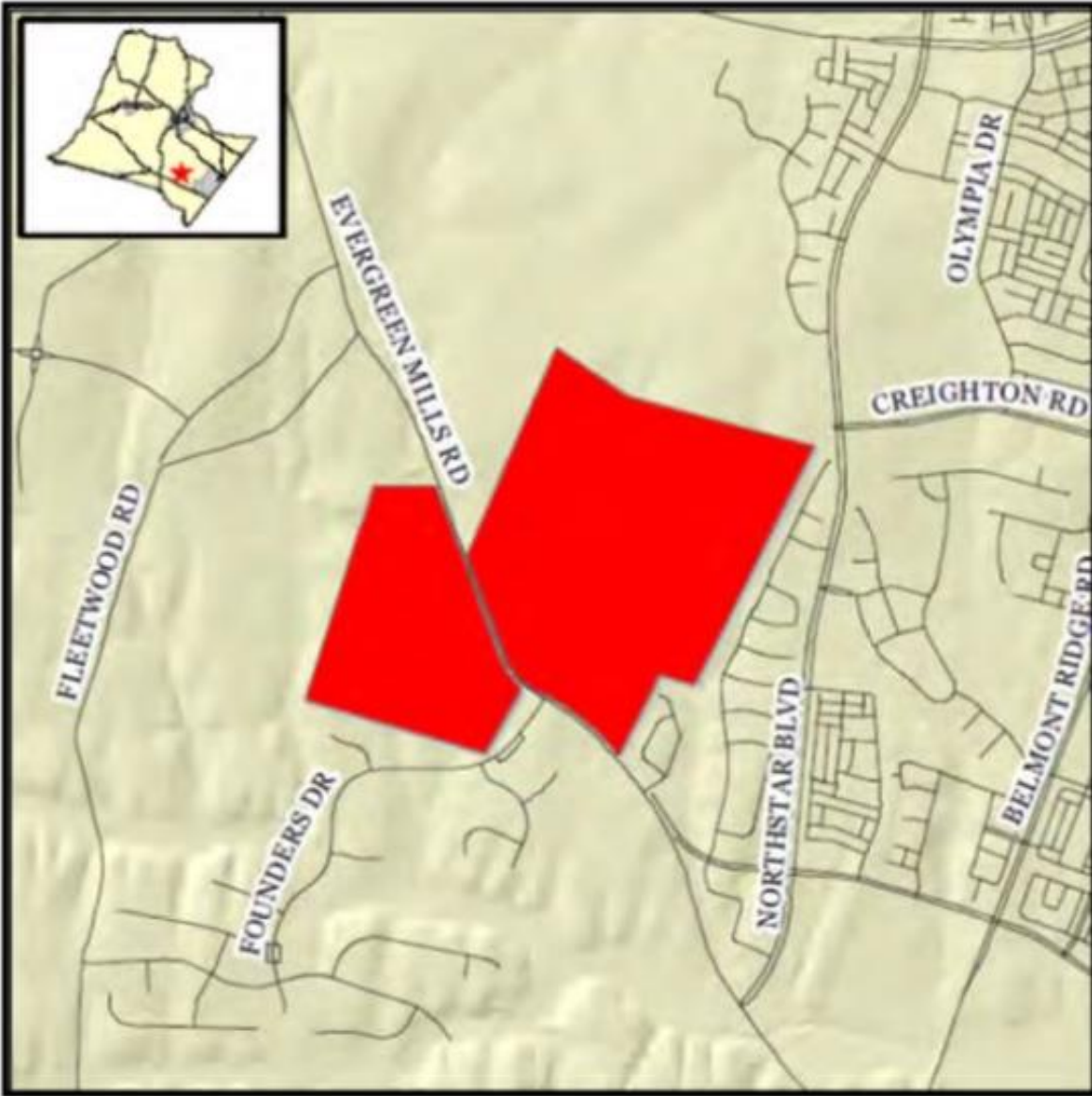
