On May 26, 2015 a young male consumer (bking # 14-02400) came into the ADC on a DIP. He was to be released when his hold time was up. A CIT trained deputy was requested by ADC intake staff to speak with the consumer. CIT trained Deputy Wilhelm met with the consumer and immediately contacted MH staff at the ADC. He was concerned that this individual was suffering from a mental illness and was able to delineate his concerns. His intervention was appropriate and timely. As a team we were then able to ECO this consumer to a local hospital on his release from the ADC. A TDO followed. Today this consumer is safely in a hospital where he can receive treatment.

I would like to commend Deputy Wilhelm for the work he did.

On 5/12/2015 at approximately 9:30pm my daughter called me in a panic stating she heard a window break and thinks someone is in the house. My heart dropped and I left work to rush home concerned for my family. I work at the big Verizon Campus on Loudon County Parkway so I'm only 3 minutes away from home. My neighbor called 911 while I was turning into the community where I live. When I arrived I saw the window on the 2nd level (living room) missing from the frame. I cautiously went in to check things out and verified the window was not secured properly. The wind pushed it in making quite a commotion when it fell onto a table. Officer Eddie Jappell showed up 30 seconds after me, I went outside to greet him. My neighbor and I were standing outside and it was kind of dark. Officer Jappell was extremely kind, courteous, and professional. Of course he was a little cautious as he should be. I had my driver's license out as he approached so I could be identified. We went inside, and I explained what happened. I invited Officer Jason Gadell in also. These guys looked like they were prepared for any and all situations. The response time was absolutely amazing and these officers were clearly trained at the highest level. I also had the pleasure of speaking with Sgt. Rogers who made me feel comfortable knowing this community is in good capable hands. I don't have much interaction with police officers but I felt comfortable with all 3 of these gentlemen. I want all of your officers to know that not everyone believes what the media chooses to sensationalize. The citizens of Loudon County are smart enough to know the media is trying to get high ratings by creating tension between citizens and the police. I know there are some bad officers out there and I've personally met a few but I believe there are way more good than bad. The reporting needs to be more balanced.

In closing I'd like to say much respect to all of the good officers in uniform that are man enough, or woman enough to answer those 911 calls.
