- List of fireworks proposed for sale in Loudoun County. Where the testing is managed by another participating jurisdiction, a copy of the list to be submitted to that jurisdiction will suffice. The list must include the name, part number and last AFSL test date (Note b) for each item.
- Proof of a corporate surety bond or a public liability insurance policy in an amount not less than \$5,000,000.00, naming the County of Loudoun as an additional insured. Issuer must be licensed to do business in Virginia.
- Check or money order payable to 'County of Loudoun'
